May is Scams Awareness Month!

Citizens Advice warns that as people across the country struggle to make ends meet they are being sized up by devious con artists. Scammers are targeting the elderly and desperate people with squeezed finances to swindle them out of their money.

Fraud offences in England and Wales rose by 25% in 2013, compared to the previous year, with 207,252 cases reported to Action Fraud and the police. But Citizens Advice has calculated up to four million people could be scammed each year as many scams go unreported.

Citizens Advice, Citizens Advice Scotland and the Trading Standards Institute launch Scams Awareness Month and throughout May are urging people to "fight back against the fraudsters".

People are just as likely to be conned over the phone and via text messages as they are through emails and websites. New analysis reveals:

- •Over a third of scams (34%) were over the phone
- •Almost a quarter of scams (24%) were through visits to a web site
- •16% were letter or fax scams
- •One in ten scams (10%) were through emails

We are warning that people should watch out for non-secure websites that ask for financial details. It's important that people realise scammers are also at the end of the phone and on your doorstep.

Email claiming to be from Amazon UK: (information via Hoax-slayer.com)

The email (pictured) claims that the company undertakes 'integrity checks' on user accounts and that the recipient is required to click on a link within the next 24 hours to prevent their account being disabled permanently.

The email is not connected in any way with Amazon UK and customers are not required to validate their account in this way. If you receive this email delete it without clicking on any links.

Most pirate film/TV websites contain malware and scams

97% of the most visited illegal film and TV sites contain malware or credit card scams according to a report by the Industry Trust for Intellectual Property Awareness. The group whose members include Amazon, BBC Worldwide, HMV, BSkyB, Sony and Walt Disney analysed 30 of the most visited sites offering access to copyright infringing material, and indicated only one was free of such threats. Allergy Awareness Week 2014

Caterers - Are you aware that you need to provide allergen information for ALL the food you serve from 13th December 2014?

Top five things you need to know:

- 1. Caterers need to provide information to customers on all 14 allergens present in the ingredients in all the food they serve
- 2. Accurate and complete allergen information needs to be given at the point where the customer chooses their food
- 3. If the information is given verbally, the business will have to indicate that customers can ask a member of staff for information about the ingredients containing allergens in the food
- 4. The correct terms must be used for allergens, as specified in the regulations
- 5. The business will not be able to say they don't know or cannot guarantee what allergens are in the ingredients used to prepare their food

Allergens Coming to a food label near you



The way allergens are labelled on prepacked foods is changing because of new regulations. The Food Information Regulation, which comes into force in December 2014, introduces a requirement that food businesses must provide information about the allergenic ingredients used in any food they sell or provide.

There are 14 major allergens which need to be mentioned (either on a label or through provided information such as menus) when they are used as ingredients in a food. Here are the allergens, and some examples of where they can be found:



Celery

This includes celery stalks, leaves, seeds and the root called celeriac. You can find celery in celery salt, salads, some meat products, soups and stock cubes.

Cereals containing gluten

Wheat (such as spelt and Khorasan wheat/Kamut), rye, barley and oats is often found in foods containing flour, such as some types of baking powder, batter, breadcrumbs, bread, cakes, couscous, meat products, pasta, pastry, sauces, soups and fried foods which are dusted with flour.





Crustaceans

Crabs, lobster, prawns and scampi are crustaceans. Shrimp paste, often used in Thai and south-east Asian curries or salads, is an ingredient to look out for.



Eggs are often found in cakes, some meat products, mayonnaise, mousses, pasta, quiche, sauces and pastries or foods brushed or glazed with egg.





Fish

You will find this in some fish sauces, pizzas, relishes, salad dressings, stock cubes and Worcestershire sauce.

Lupin

Yes, lupin is a flower, but it's also found in flour! Lupin flour and seeds can be used in some types of bread, pastries and even in pasta.

Did You Know?

Did you know that £50 banknotes carrying the portrait of Sir John Houblon were withdrawn from circulation on 30th April?

From now, only the £50 banknote featuring Matthew Boulton and James Watt, which was introduced in 2011, will hold legal tender status and general retailers are unlikely to accept the Houblon notes as payment.

Microsoft release security update for Internet Explorer flaw

Microsoft has released security update for Internet Explorer that closes a gap that allowed attackers to take complete control of a computer

Microsoft has said users of its Windows XP operating system will also get the security update. Microsoft ended support for Windows XP earlier this month, ceasing to issue bug fixes or security updates for it.

The flaw affected Internet Explorer (IE) versions 6 to 11 and Microsoft said "limited, targeted attacks" had occurred. The company has now <u>issued an update</u> on Thursday to fix the bug. https://technet.microsoft.com/library/security/ms14-021

Clesse Automatic Changeover Regulator With OPSO

Potentially Faulty Defibrillators - safety notice

First aiders in shopping centres, railway stations, dental surgeries and other public places are asked to identify if they have a specific defibrillator that could potentially give incorrect advice to anyone using it to give CPR to someone having heart problems.

The defibrillator – called the samaritan® PAD 500P defibrillator made by Heartsine Technologies Ltd – has a software fault that may incorrectly advise the user to 'push slower' during CPR when, in fact, the CPR rate is at an acceptable level.

The Medicines and Healthcare products Regulatory Agency (MHRA) has issued an alert about this issue following a global correction notice issued by the manufacturer that provides advice about how first aiders and anyone responsible for these defibrillators can update the software.

The serial numbers for defibrillators affected are from 10B0010001 to 14B00461703 and they were sold in the UK from August 2004 to December 2010.

John Wilkinson, the MHRA's Director of Medical Devices, said:

"It's vital that first aiders or anyone who is responsible for a defibrillator used in public places such as shopping centres, railway stations and dental surgeries check the serial numbers to see if they have one of the affected defibrillators that needs its software updating.

"If they do, people can contact the manufacturer's helpline on 0845 604 8280 who can provide advice about how to update the software or the MHRA Adverse Incident Centre on 020 7084 3080 or aic@mhra.gsi.gov.uk ."

Faulty Belt Sold Together With Girl Leggings at H&M

H&M recalls the belt sold together with these girl leggings in sizes 92 and 98. Customers are asked to immediately remove and stop using the belt. The customers are kindly asked to return the belt, or the

leggings together with the belt, to any H&M store for a full refund.

The metal components that hold the belt together can break into small parts. Small parts are known to be a risk of choking, ingestion or inhalation for children below 3 years of age.

H&M has been informed about one incident involving the belt. No injury has been reported.



Pride S74 Elite Sport Scooters - safety notice

The following notice has been issued by the Medicines and Healthcare Products Regulatory Agency:

People who use S74 Elite Sport scooters manufactured by Pride Mobility Products Ltd are today being asked to check if they have faulty scooter batteries. The batteries can overheat and swell during the charging process, resulting in a reduced range of travel, or the scooter failing to drive as expected.

The Medicines and Healthcare products Regulatory Agency has issued a medical device alert after the manufacturer received several incident reports regarding these mobility scooters, where the batteries had become swollen. The mobility scooters are used by over 400 people in the UK. No injuries are known to have been sustained as a result of the battery incidents; however people are urged to stop using the affected models until the batteries are replaced.

Pride Mobility Products Ltd issued a Field Safety Notice (FSN) in February 2014 to warn people with S74 scooters that contain Leoch 20 amp/hour batteries that they should contact their dealer for replacement batteries. Unfortunately, the manufacturer has had difficulty tracing all of the affected scooters.

Anyone who has an affected S74 Elite Sport Pride Mobility scooter should contact the dealer who they purchased the scooter from or alternatively the manufacturer on 01869 324600 to arrange for free replacement batteries to be fitted.
