P-133 APOLOGIES

P-134 DECLARATIONS OF INTEREST

P-135 MINUTES OF PREVIOUS MEETINGS

RESOLVED: The minutes of the meeting held on 28 July 2022 were approved as a true record.

P-136 QUESTIONS FROM THE PUBLIC

On application **22/P/01099** there was a concern raised re domestic use of a garage on the application. The member of public questions their long terms plans as it appears that a large proportion of land is to be annexed off. The resident feels that if successful, the application would infringe on a number of people's privacy.

P-137 PLANNING APPLICATIONS

Members discussed each application and approved the Clerk to respond on behalf of the council.

2/P/01207 Land to the east of, Glaziers Lane, Normandy, GU3

Proposed erection of 8 two storey dwellings (4 detached and 4 semi-detached) with associated parking and gardens at Glaziers Lane, Normandy, Guildford.

RESOLVED: The Council objects in relation to previous planning decisions, not in the local plan, the development is on a flood plain, there is no special reason to build on a development on a green belt and highway safety. The council do not see this as an infill.

22/P/01208 Verdure, Westwood Lane, Wanborough, Guildford, GU3 2JJ

Variation of Condition 2 (drawing numbers) of planning application 20/P/02132 approved 20/04/22 to amend the site plan drawing SK-03 to be replaced by SK-03B and proposed elevation SK-07 to be replaced by SK-07A.

RESOLVED: The Council offers no comment

22/P/01174 9 Pirbright Road, Normandy, Guildford, GU3 2AG

Proposed two storey rear extension and new garage following demolition of existing garage.

RESOLVED: The Council offers no comment

22/P/01107 Land to the west of North Wyke Farm, Guildford Road, Normandy, GU3 2AN

Demolition of the existing stables and outbuildings and the erection of a single storey dwelling.

RESOLVED: The Council objects in relation to not in the local plan, there is no special reason to build on a green belt and this may encourage ribbon development. This appears to be using someone elses's land.

22/P/01099 The White House, 57 Glaziers Lane, Normandy, Guildford, GU3 2DF

Conversion and alterations to an outbuilding to create a detached two bedroom dwelling with three rooflights and some changes to fenestration.

RESOLVED: The Council objects in relation to overlooking/loss of privacy to a number of houses, limited road access, to the location of the building, noise and disturbance resulting from use, development in green belt land and not in the local plan.

Removal of condition 2 (pond use) of planning application 22/P/00410 approved 22/06/2022.
