Members discussed a recent report from Cllr Witham (GBC)

- (a) It was noted GBC's Planning remains close to special measures meaning that decisions will be taken by the planning inspectorate directly rather than through GBC planning. GBC leadership have hired consultants to support.
- (b) It was further noted there is no appeal against an approval.
- (c) North Street development will be determined either on appeal with some amendment to the original application or with a separate application made.
- (d) Cllr With met Cllr Potter who is the lead councillor for planning and enforcement. He assured there will be action on Palm Nurseries, Wanborough Fields and the house opposite the motorcycle shop in Normandy.
- (e) It was also reported that the established use caravan park along Flexford / Worplesdon direction appears to be getting little attention.

The next Planning meeting is 10 August, there are two planning applications with deadlines ahead of this meeting, due to holidays of Councillors an interim meeting can not be called. The Assistant Clerk will request an extension from GBC of the deadline for comments.
